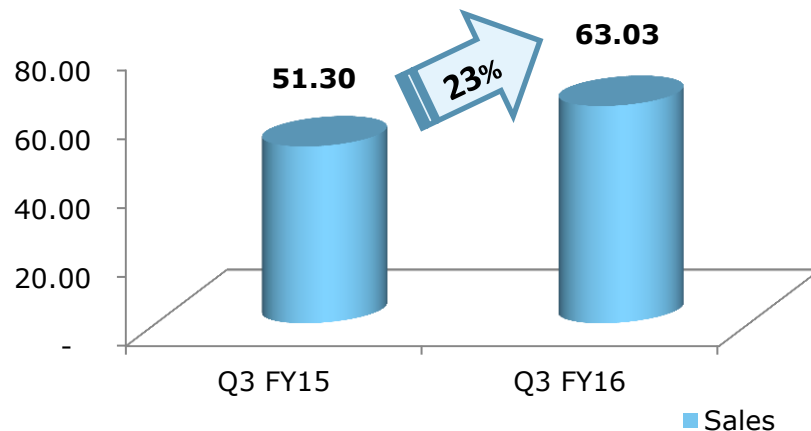
- Average occupancy increased to 78% from 77% QOQ and from 72% YOY

Pallet Capacity



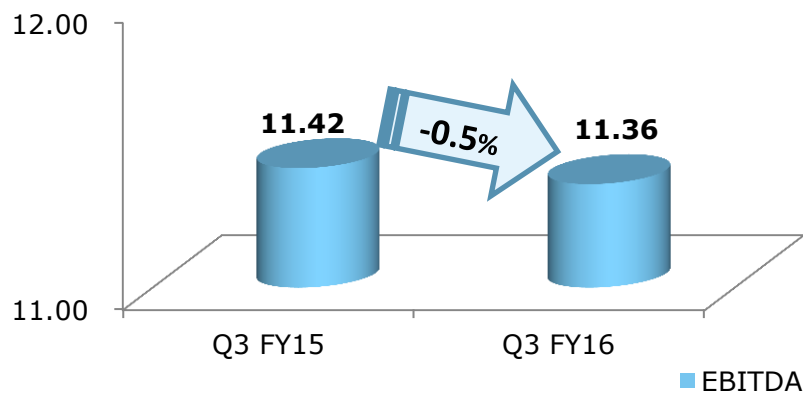
Sales

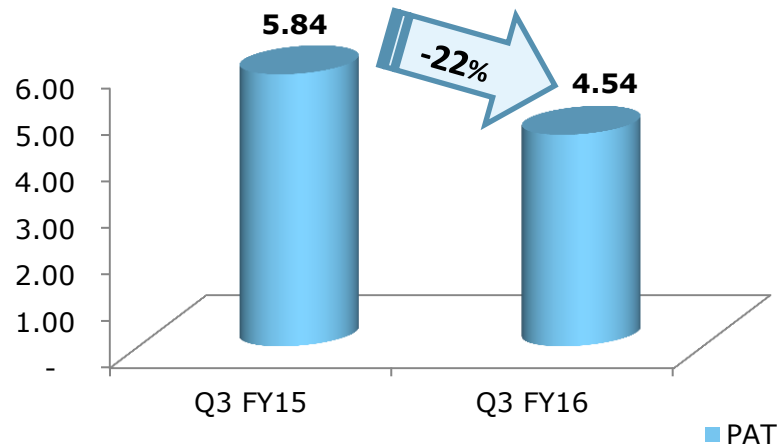
EBITDA

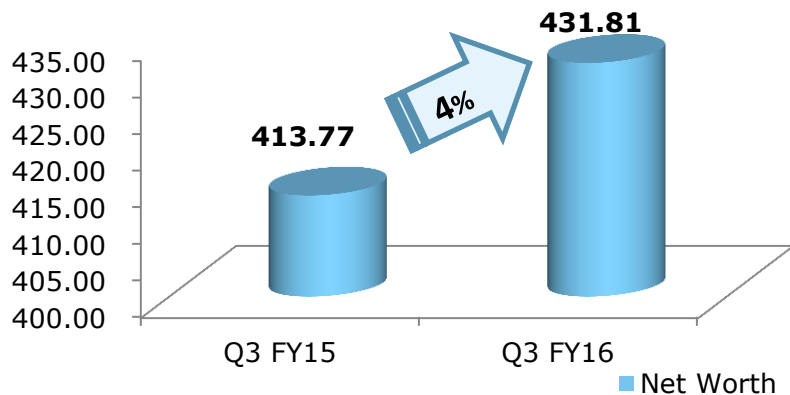

Net Worth, Fixed Assets & Debt

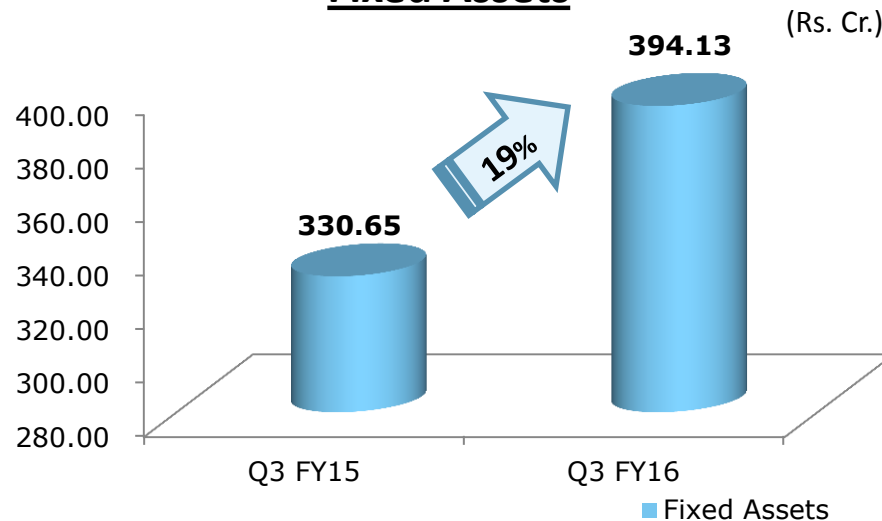
Net Worth

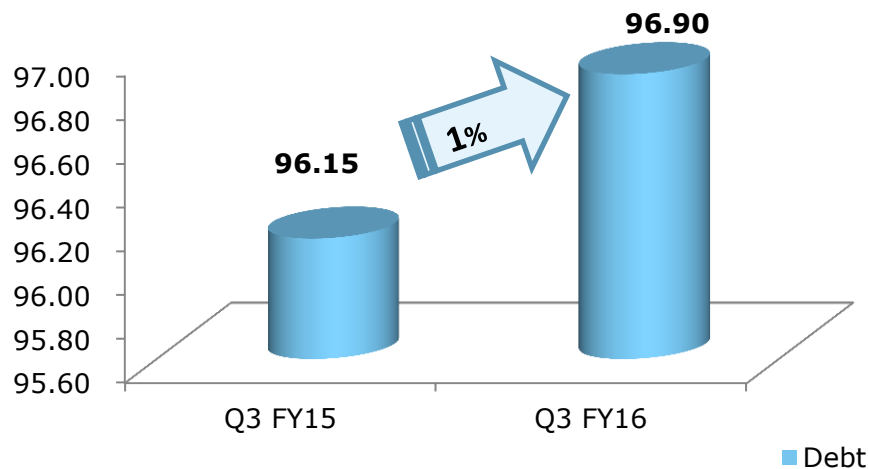
Fixed Assets

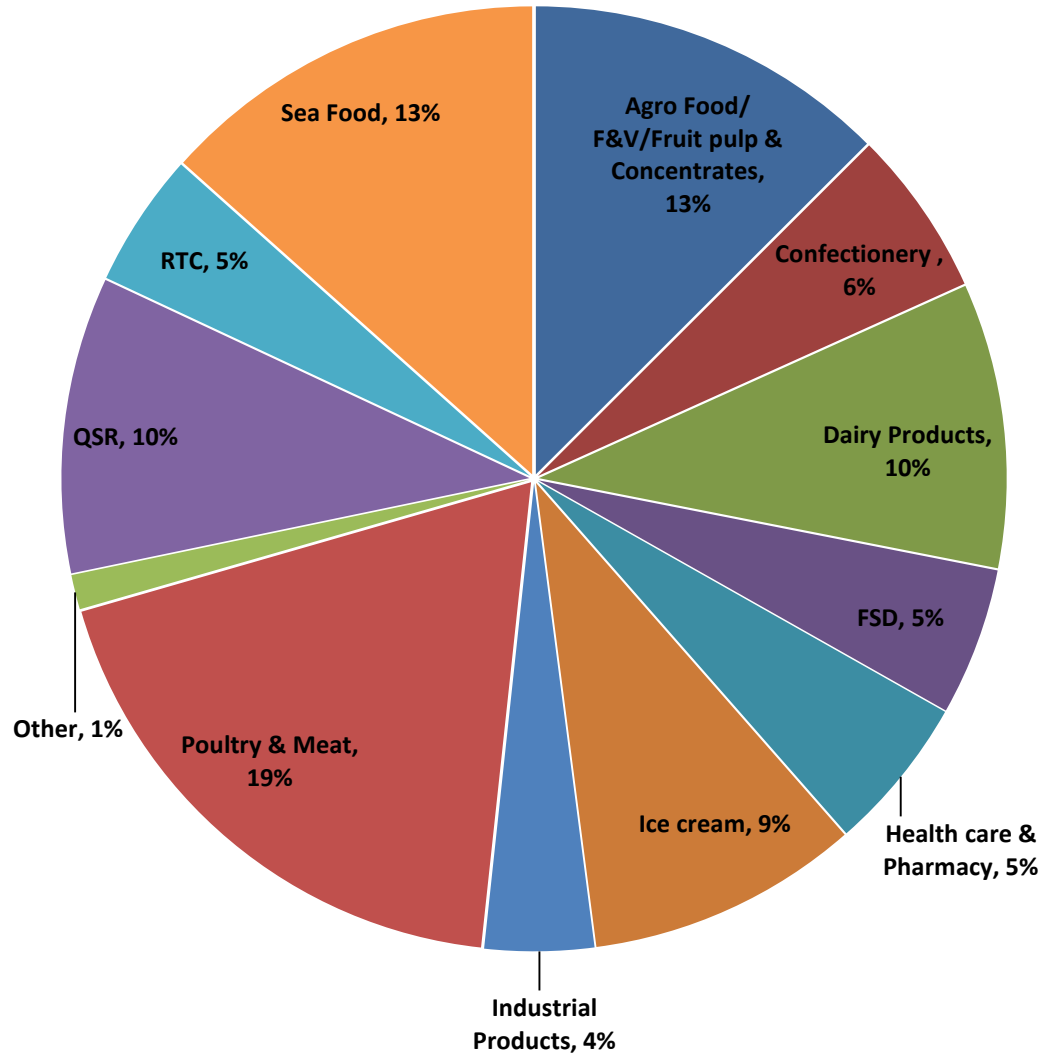
